Billing:

Memberships are auto-debited on the first of each month. If you sign up for a membership outside of the first day of the month, then you will be pro-rated accordingly.

Long Term Agreements:

Memberships are a month-to-month minimum; options for long-term agreements on page 2.

Cancellation Policy:

All memberships require a **30 day minimum** written notification to cancel. If a membership is cancelled after the first of the month, the member will be pro-rated into the following month for their final payment.

Cancellation with Long Term Agreement:

Above cancellation policy applies - in addition - If a long term agreement is broken, the previous month savings will be included to the final payment.

Conference Room Credits:

Credits do NOT accumulate. Each month, credits regenerate. A member may not sell or lend their credits to another member or non-member.

I understand my account will be billed on the first of each month on a recurring basis.
